**THESE FEES ARE NON-REFUNDABLE.**
- Camper Sites are **NON-TRANSFERABLE & NOT FOR RESALE; ONLY BY WPOHA**; however it's your responsibility to **ALWAYS** notify the Show Secretary, if you will not be using the site. Be aware that failure to notify Show Secretary will **forfeit** your reserved camping privileges for the remainder of the 2020 year. This is being done to ensure that all camper site are utilized and that as many people as possible are accommodated with available camper sites at each show. Be aware that the camper sites will be monitored at each show to insure they are occupied by the person assigned to that camper site. Remember if a non-assigned person is in the Site they will be charged by WPOHA. No Refunds to renter of camp space.
- If Campers, arrive early, stay over, and/or are left in between Show Dates there is an additional campsite fee of \$150.00 that must be paid in advance. (The vehicle left must **ALWAYS** be disconnected from water and electrical service.) If any camper is left on the grounds without notify the Show Secretary, it will be towed at the owner expense.
